2011-2012 National Award Guidelines

DEADLINE:

All nominations are due to FCCLA National Headquarters postmarked by April 1, 2012.
Nominations sent after the April 1, 2012 postmark deadline **will not** be considered.

ELIGIBILITY:

The award will be presented to a current chapter adviser of FCCLA who integrates one or more core academic subjects (language arts, mathematics, social studies, science) into Family and Consumer Sciences education and/or FCCLA projects and activities.

CRITERIA:

Nominees will be judged based on their integration of core academics into FACS course work and FCCLA projects and activities, as well as their efforts to share these techniques with other educators and increase awareness of FCCLA's relationship to core academics.

- Use only the space provided for the nominee information.
- Additional information will not be considered in the award selection, except for letters of recommendation, lesson plans, and handouts used in the integration programs.
- Projects included on the application should have been completed between March 1, 2012 and March 1, 2012.
- Maximum points that may be awarded by judges are indicated in parenthesis after each criterion:
 1. Active affiliated FCCLA chapter (15)
 2. Examples of integration of core academics into FACS coursework and FCCLA projects and activities (25)
 3. Presentations and efforts to share techniques with other teachers and advisers (20)
 4. Public relations efforts to increase awareness of integration of academics (20)
 5. Three letters of recommendation (15)
 6. Overall presentation of application (5)

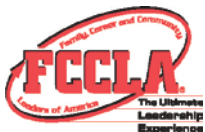
